# TOWER D - TYPICAL FLOOR PLAN



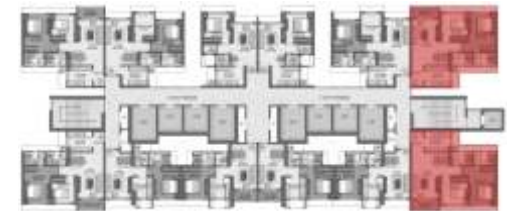

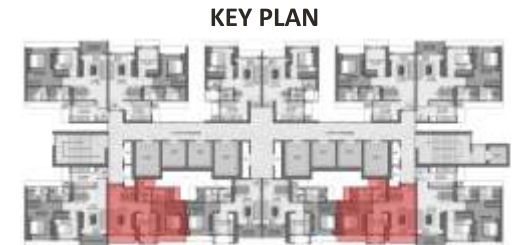
